II. Acceptance of KITE Meeting Minutes – June 7, 2023

a. The June 7, 2023, KITE Meeting Minutes were approved.

III. School Readiness Business/Quality Enhancement Update

- **a.** All 28 slots at Enfield Child Development Center are still full at Enfield Child Development Center and the monthly report was just submitted to the Office of Early Childhood.
- b. Classroom monitoring has been conducted including a sampling of 5 child files and everything went well. Staff are in the process of updating their professional development records. All staff are in compliance with the required Health and Safety training. Lisa Carriere who is the Parent Educator at Barnard FRC and has early childhood classroom experience is going to be assisting with monitoring this year.
- **c.** General Policies have been updated and copies are available.
- **d.** Quality Enhancement: Through the School Readiness Grant, we receive \$3,881 in funds to focus on improving the quality of the program. Last year we worked with Melanie Smith-Cervera from EastConn on helping teaching staff incorporate more strategies on purposeful play and executive function. The grant allows us to work with EastConn again this year. Next week, Eileen, Heather Pinto-Cohn and Amy are meeting with Melanie to plan for the work this year which will focus on increasing Heather's abilities to assist.
- e. McKinney Vento Update: Julie Carroll reports that currently there are 25 homeless student's total (6 are in grades PK-2).

- f. Karen Edelson shared that ECDC is hiring a toddler teacher and will be starting home visits for new families.
- g. Open house will be held on October 4th for the entire Stowe building.
